TIP SHEET: EVIDENCE IN SUPPORT OF DRG INTEGRATION

DRG Officers and other development specialists often seek research-based evidence that DRG integration works as a positive force for development outcomes across sectoral boundaries. There is a growing body of literature studying the connections between governance, sectoral outcomes, and sustainable development. In addition, USAID commissioned a number of Impact Evaluations in place such Guatemala, Malawi, and Nepal to study the effectiveness of DRG integration.
